## Office Order

M/s ANG Lifesciences India Ltd. has a rate contract no. 20210016601 (17-Jun-2021 to 16-Jun-2023) with this Corporation for the supply of drug "METFORMIN HYDROCHLORIDE: 500 mg (Tab)". Uttar Pradesh Medical Supplies Corporation Ltd. has issued purchase orders vide 10282202650 dated 13-Jun-22, 10282201446 dated 04-Mar-22, 10282106929 dated 22-Dec-21 for supply of METFORMIN HYDROCHLORIDE: 500 mg (Tab) to various Distt. Drug warehouse. Company had not supplied the above said purchase orders issued by Uttar Pradesh Medical Supplies Corporation Ltd. as per tender terms and conditions.

Notice to the Company M/s ANG Lifesciences India Ltd. was sent through letter vide UPMSCL/Drugs/2022/969 dated 20/09/2022 regarding non-supply of purchase orders for METFORMIN HYDROCHLORIDE: 500 mg (Tab) issued by Uttar Pradesh Medical Supplies Corporation Ltd.

The response of the Company received through letter vide ANG/22-23/518 dated 22/09/2022 was given due consideration but the Company's request to extend the supply period of above purchase orders without any penalty charges of late supply is not found satisfactory and justifiable as per tender conditions.

Company M/s ANG Lifesciences India Ltd. has not supplied purchase orders vide 10282202650 dated 13-Jun-22, 10282201446 dated 04-Mar-22, 10282106929 dated 22-Dec-21 and thus Company has violated the tender condition of tender ref. No. UPMSCL/Drug-67/235 dated 05.09.2020, Section-III Clause 13. Debarring & Blacklisting, point-ii. i.e. "If the Supplier fails to execute at least 70% of the order quantity for any particular drug for more than two purchase orders, then the Supplier shall be debarred for supply of that particular drug for a period of two years. Hence, company M/s ANG Lifesciences India Ltd. is, hereby, debarred for the drug "METFORMIN HYDROCHLORIDE: 500 mg (Tab)" from participating in tenders floated by Uttar Pradesh Medical Supplies Corporation Ltd. for two years from the date of issue of this office order.
